**ORDINANCE NO. 466**, as follows: AMENDING THE WALLA WALLA/COLLEGE PLACE COORDINATED WATER SYSTEM PLAN (CWSP) BY REMOVING PROPERTY FROM THE CITY OF WALLA WALLA'S WATER SERVICE AREA (WSA), IDENTIFIED BY PARCEL NUMBERS 360605514809 (1.23 acres) AND 360605510006 (10.43 acres), AND OWNED BY SUNSET DEVELOPMENT, LLC, AND REQUIRING THAT ANY NEW PUBLIC WATER SYSTEM BE CONSTRUCTED IN ACCORDANCE WITH THE CONSTRUCTION STANDARDS AND SPECIFICATIONS EMBODIED IN THE CWSP, AND THAT ANY SUCH NEW PUBLIC WATER SYSTEM SHALL BE OPERATED BY A STATE APPROVED SATELLITE MANAGEMENT AGENCY.
