2024 Candidate filing begins Monday, May 6<sup>th</sup> and closes on Friday, May 10<sup>th</sup>.

Online filing is available starting Monday May 6<sup>th</sup> at 8:00am until 5:00pm Friday May 10<sup>th</sup> at 5:00pm.

In addition, candidates may file in-person at the Elections Office, 315 W. Main St., Room 203 or by mail.

Office hours are Monday - Friday, 8:00 a.m. to 5:00 p.m.

The submitted information must be legible, timely and satisfy all legal requirements (RCW 29A.04.255 and WAC 434-208-060). Candidates are responsible for ensuring they meet all qualifications for that office.

If a fee is required, the electronic filing is not complete until the fee is received. The fee must be received by 5:00 p.m. on Friday, May 10<sup>th</sup>, 2024 (WAC 434-208-060). Credit Card payments will be accepted through the online filing process.

Filing Fees are **NOT** refundable.
