Brief Duties and Responsibilities: Provides support to corrections officers and administrative staff while maintaining the security of the Walla Walla County Corrections Department. Work involves monitoring and operating the jail security system in the Control Room.

Working Environment/Physical Abilities: Duties are performed in the Walla Walla County Corrections Control Room. Most duties can be performed while seated. Requires ability to lift thirty (30) pounds and may require travel. Requires manual dexterity and visual acuity to operate a computer.

Minimum Qualifications: Experience, Education And Training: Graduation from high school or have obtained a GED. Applicant must have any equivalent combination of training, education and experience which would provide the individual with the required knowledge, skills and abilities to perform the job as outlined.

Walla Walla County Position Description

JOB TITLE: PT Control Room Officer

DEPARTMENT: Walla Walla County Corrections Department

REPORTS TO: Deputy Operations Commander

PAY GRADE: 2; Part Time, Variable hours, On Call

JOB SUMMARY: Provides support to corrections officers and administrative staff while maintaining the security of the Walla Walla County Corrections Department. Work involves monitoring and operating the jail security system in the Control Room.

SUPERVISIORY RESPONSIBILITIES: None

ESSENTIAL FUNCTIONS:

- Controls public access to the Corrections Department.
- Ensure all equipment within the Control Room is in good working order and requests repairs or replacements as necessary.
- Monitors and controls the movement of jail personnel, inmates and visitors within the jail utilizing T.V. monitors, radios and intercoms; monitors security systems such as housing alarms, door hinge alarms, fire alarms and panic button alarms.
- Reviews and records inmate activities using video surveillance system.
- Observes and responds to unauthorized movements and emergency situations.
- Maintains radio communications with officers throughout the jail.
- Schedules, processes and documents inmate and jail visitors.
- Answers incoming phone calls from the public.
- Maintains required logs and reporting requirements.
- Receives information regarding persons on transport and logs the information in the Control Room log.
- Updates New World booking software with court updates and writes incident reports when necessary.
- Assists with processing of warrants.

EXPERIENCE, EDUCATION AND TRAINING: Graduation from high school or have obtained a GED. Applicant must have any equivalent combination of training, education and experience which would provide the individual with the required knowledge, skills and abilities to perform the job as outlined.
