**Terms & Conditions**

1. The taxpayer agrees to pay 50% of the second-half payment, in the amount of \$\_\_\_\_\_ by no later than November 2, 2020.
2. The taxpayer agrees to pay the remaining 50% of the second-half payment by no later than November 30, 2020, without incurring interest.
3. The taxpayer understands that if payment is missed, interest and penalties will apply according to RCW 84.56.020.
4. The taxpayer understands that any payments returned or declined for insufficient funds or other reasons will result in immediate termination of this agreement and will incur a \$35.00 Bank Returned Item Fee.
5. The Taxpayer understands payments can be made online at [https://www.co.walla-walla.wa.us/government/treasurer/payment\\_center.php](https://www.co.walla-walla.wa.us/government/treasurer/payment_center.php) using an electronic check (no fee) or debit/credit cards (a convenience fee is charged), by mail to: Walla Walla Treasurer's Office, PO Box 777, Walla Walla, WA 99362 or by using one of our secured drop boxes located in the alley behind the Courthouse or behind the City of College Place City Hall. Payments by mail must be federally postmarked by the due date established to be considered timely.
6. The taxpayer understands that the Treasurer's Office will not be sending reminders or notices regarding payment due dates.
7. The taxpayer understands that this agreement and the payment plan history may be subject to Public Disclosure pursuant to RCW 42.58 if request.
8. Prior to making the final payment, contact the Treasurer's Office to confirm the final payment amount.

**Laws, venue, and jurisdiction:** This Agreement shall be governed by the laws of the State of Washington. Any action, suit, or judicial proceeding for the enforcement of this Agreement shall be brought in the Superior Court for the State of Washington in Walla Walla County, Washington.

**Severability:** If any term of this Agreement is held invalid by any court, the remainder of the Agreement remains valid and in full force and effect.

**Waiver:** Waiver of any breach or default on any occasion shall not be deemed to be a waiver of any subsequent breach or default. Any waiver shall not be considered to be a modification of the terms and conditions of this Agreement. Only

the Walla Walla County Treasurer has the authority to waive any term or condition of this Agreement on behalf of the County.

I own property in Walla Walla County, have been affected by the State of Emergency declared under RCW 43.06.010(12) regarding the COVID-19 Pandemic, and am unable to pay the full amount of the second half 2020 real or personal property taxes due November 2, 2020. I attest there is no active escrow with a mortgage company for the payment of taxes associated with the parcel(s) listed above.
